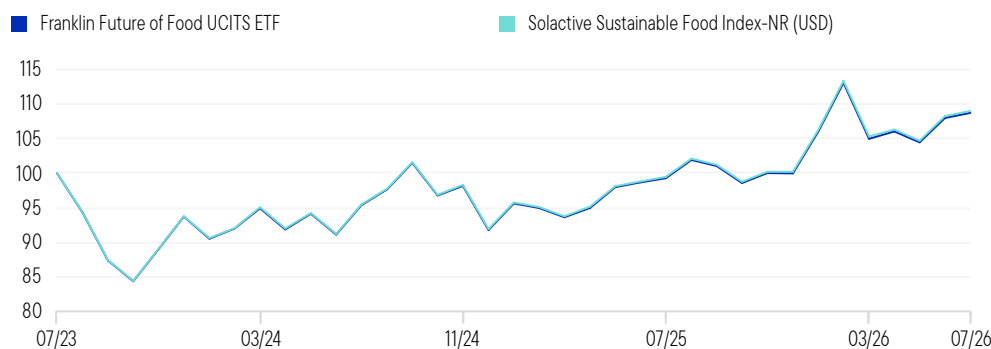

Glossary
