What is this product?

Type

The product is a share class of FTGF Western Asset Short Duration Blue Chip Bond Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek to maximise income and growth of capital (total return).

Investment Policy

The Fund mainly invests in high quality investment grade (or comparable) corporate bonds issued by well-established companies considered to be blue-chip (long-term debt rating of A- or higher by S&P). The Fund will attempt to hedge almost all non-USD exposure to USD. These investments are from developed markets only.

The Fund maintains an average duration below 5 years at the portfolio level (meaning it is less sensitive to interest rate changes than longer duration bond Funds). The Fund will invest only in corporate bonds that in the opinion of the investment manager, are ranked at least senior unsecured corporate debt securities of the relevant issuer.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

The Fund is actively managed without reference to a benchmark.

Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class, the manager intends to apply a NAV hedge "(Hedged)" which intends to minimize fluctuations between the base currency of the fund and the share class currency.

For this share class certain fees and expenses may be charged to capital rather than income. This will result in an increase in income available for distribution by foregoing some of the capital that the share class would have available for future investment and potential growth. In addition, all or some portion, of realised and unrealised capital gains net of realised and unrealised capital losses may be declared as a dividend.

Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange is open for business.

Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 3 years. The Fund may appeal to investors who:

- are looking for a combination of income and investment growth
- are interested in exposure to developed bond markets as part of a diversified portfolio
- have a medium risk profile and can tolerate short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

Terms to understand

bonds, investment grade: Bonds represent an obligation to repay a debt, along with interest. Investment grade bonds are considered to have a lower risk of becoming unable to make promised payments to investors, including the initial debt.

derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

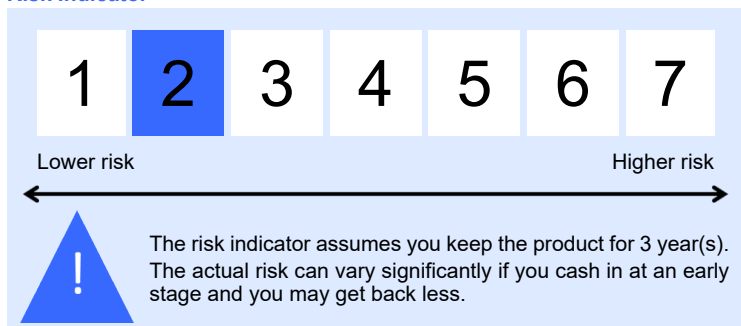

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
