What is this product?

Type

The product is a share class of FTGF Putnam US Research Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To generate long-term capital appreciation.

Investment Policy

The Fund will mainly invest in equity and equity-related securities of large US companies. The investment manager will look for investments among a strong core of growth and value stocks.

To a lesser extent, the Fund may also invest in debt securities of US and non-US issuers as well as asset and mortgage-backed securities.

Derivatives and techniques The Fund may invest in derivatives only for efficient portfolio management purposes.

Strategy In selecting securities, the Investment Manager integrates consideration of material ESG issues in the fundamental research process. The Investment Manager considers ESG analysis as additive and complementary to the fundamental understanding that is at the center of its investment philosophy.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary ESG methodology using various ESG criteria to assess long-term opportunities and risks. The Fund restricts investments in certain industries that are harmful to the environment or society, such as weapons and tobacco.

Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

For this share class, the manager intends to apply a NAV hedge "(Hedged)" which intends to minimize fluctuations between the base currency of the fund and the share class currency.

Buying and selling shares

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for long-term investment growth
- are interested in exposure to equity markets of US companies (mainly blue-chip)
- have a high risk profile and can tolerate short-term changes in the share price.

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

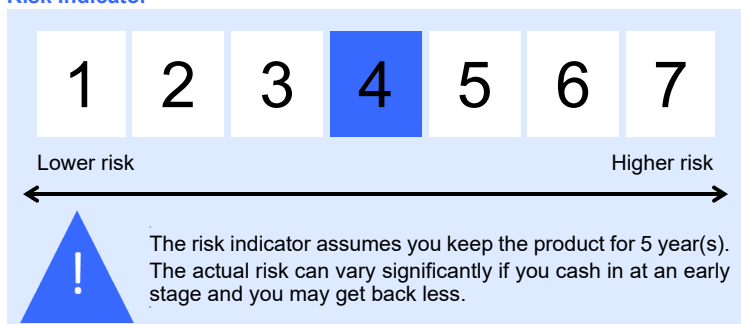

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- SGD 20 000 is invested
