What is this product?

Type

The product is a share class of FTGF Pathway to Putnam US Research Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To generate long-term capital appreciation.

Investment Policy

The Fund will pursue its investment objective while gradually shifting exposure from the Euro Government Bond Strategy to the US Research Strategy over a four-year-life-cycle (the "Life-Cycle") on a staged basis. The Fund will launch with a target of investing 80% of its assets in accordance with the Euro Government Bond Strategy and a target of investing 20% of its assets in accordance with the US Research Strategy. At the end of the first two-month period following the launch of the Fund, the Investment Manager will rebalance the Fund to the same 80%/20% threshold. Thereafter, the Investment Manager will rebalance the Fund at the end of each calendar quarter by increasing the Fund's target exposure to the US Research Strategy on a linear basis by 5% over the remainder of the intended Life-Cycle of the Fund. At the end of the Life-Cycle, the Fund will aim to be fully exposed to the US Research Strategy.

The US Research Strategy: The US Research Sub-Investment Manager will mainly invest in equity and equity-related securities of large US companies. The US Research Sub-Investment Manager will look for investments among a strong core of growth and value stocks.

To a lesser extent, the Fund may also invest in debt securities of US and non-US issuers as well as asset and mortgage-backed securities.

The Euro Government Bond Strategy: The Euro Government Bond Sub-Investment Manager will mainly invest in investment grade obligations of government and government-related issuers as well as supranational entities located throughout the Eurozone countries.

Derivatives and techniques The Fund may invest in derivatives only for hedging and efficient portfolio management purposes.

ESG Strategy US Research: In selecting securities, the US Research Sub-Investment Manager integrates consideration of material ESG issues in the fundamental research process.

ESG Strategy Euro Government Bond: The Euro Government Bond Sub-Investment Manager may make investments in green, social, sustainability and other forms of bonds. In addition, the investment manager applies a proprietary ESG methodology using various ESG criteria to assess long-term opportunities and risks.

Investors who understand the risks of the Fund and plan to invest for at least 4 years. The Fund may appeal to investors who:

- are looking for long-term investment growth
- are interested in transitioning their exposure from fixed income to equity over the 4 year-life-cycle
- have a high risk profile and can tolerate short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

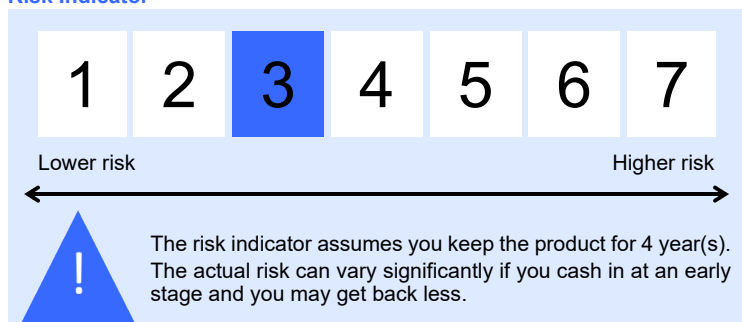

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- EUR 10 000 is invested

How long should I hold it and can I take money out early?

Recommended holding period: 4 year(s)

This Fund has no minimum required holding period. We consider that the 4 year recommended holding period is appropriate because the Fund is designed for long-term investment. You may sell your shares on any dealing day. The value of your investments may go down as well as up irrespective of the period you are holding your investments, depending on such factors as the performance of the Fund, movements in stock and bond prices, and conditions in financial markets generally.
