What is this product?

Type

The product is a share class of FTGF ClearBridge Global Infrastructure Income Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek long-term investment growth, through a combination of income and growth of capital (total return).

Investment Policy

The Fund mainly invests in equities of companies in infrastructure sectors in developed markets, such as utilities, transport, community and social infrastructure, and communications.

To a lesser extent, the fund may invest in equity and equity-related securities in emerging markets. The fund may also have limited exposure to infrastructure-related real estate funds.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy In a bottom-up process, the investment manager uses Fundamental analysis to select a concentrated portfolio of companies that appear to have a long life span, offer predictable cash flows, have low earnings volatility and benefit from limited competition due to high barriers to entry. It also favours companies that tend to be better protected from inflation.

Share Class Policy

For this share class all, or some portion of, net income is declared and paid monthly to shareholders.

For this share class, the manager intends to apply a NAV hedge "(Hedged)" which intends to minimize fluctuations between the base currency of the fund and the share class currency.

For this share class, in addition to net income being paid to investors as dividends, all or some portion of capital gains, and a portion of capital may be paid to investors as dividends. While this can increase the total dividends, it limits the potential for future capital growth.

Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange is open for business.

Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for a combination of income and growth of capital
- are interested in exposure to listed infrastructure equity markets as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through all distribution channels, with or without the need for advice.

Terms to understand

depository receipts: Certificates of ownership that allow shares to trade in markets where they are not registered.

equities: Securities that represent partial ownership of a company.

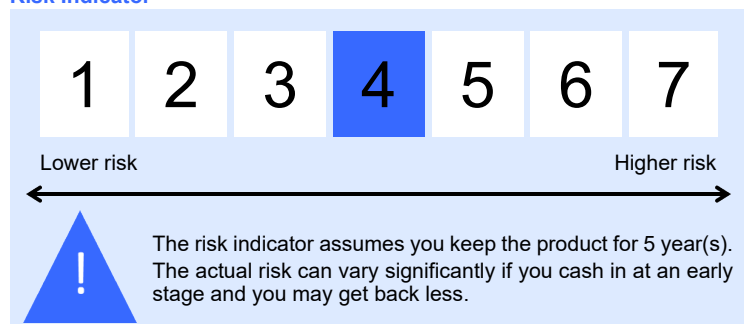

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- AUD 10 000 is invested
