What is this product?

Type

The product is a share class of FTGF Putnam Balanced Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To generate long-term capital appreciation while seeking current income.

Investment Policy
The Fund mainly invests in equities of large US companies but may also invest in US and Non-US medium and small capitalization companies

invest in US and Non-US medium and small capitalization companies (managed by the Investment Manager). To a lesser extent the fund invests in investment grade (or comparable) US and Non-US debt securities, and may invest a small allocation in below-investment-grade debt securities. The Fund will have a target exposure of approximately 60% equity and 40% debt securities.

To a lesser extent, the Fund may also invest in asset and mortgage-backed securities.

Derivatives and techniques The Fund may use derivatives for hedging, efficient portfolio management and investment purposes.

The Fund may use derivatives for reducing risks (hedging) and costs, and to generate additional income or growth.

Strategy In respect of equity investments consists of individual company selection and management of cash reserves. The investment process is designed to ensure the portfolio is exposed to companies where the team has the highest conviction while limiting exposure to any undue risk.

Debt securities are selected from various market sectors based on the Sub-Investment Manager's assessment. The Sub-Investment Manager uses a top-down analysis of macroeconomic trends combined with a bottom-up analysis of market sectors industries and issuers to identify opportunities.

Base currency US dollar (USD).

Benchmark(s) 60% S&P 500 Index and 40% Bloomberg US Aggregate Index.

The Fund is actively managed. The Benchmark is used for performance comparison purposes and is considered by the Investment Manager in portfolio construction and monitoring investment risk.

Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

Buying and selling shares

You can buy, sell and switch your shares on each day that the New York Stock Exchange is open for business.

Intended retail Investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- · are looking for long-term investment growth
- are interested in exposure to equity and debt security markets (mainly US) as part of a diversified portfolio
- have a high risk profile and can tolerate significant short-term changes in the share price.

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

Terms to understand

equities: Securities that represent partial ownership of a company.

bonds, investment grade: Bonds represent an obligation to repay a debt, along with interest. Investment grade bonds are considered to have a lower risk of becoming unable to make promised payments to investors, including the initial debt.

asset- and mortgage- backed securities: Bonds backed by consumer debt (such as mortgages, credit card and other loan-type debt) and whose income derives from the payments received from the underlying borrowers.

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs.
