What is this product?

Type

The product is a share class of FTGS Franklin Multi-Asset Conservative Fund (the "Fund") which is part of the Franklin Templeton Global Solutions plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek to maximise income and growth of capital (total return) through balanced exposure to equity and fixed income investments, denominated in US dollar, by investing in other Funds.

Investment Policy

The Fund mainly invests through other Funds ("Underlying Funds"). The Fund will mainly have exposure to equity oriented Underlying Funds and bond oriented Underlying Funds (minimum 15% and 60% of assets, respectively). These Underlying Funds may provide exposure to anywhere in the world, including, to a lesser extent, emerging markets.

The equity Underlying Funds are unconstrained in terms of investment styles and focus and the bond Underlying Funds may provide exposure to debt issued by corporations and governments, and investment and below investment grade bonds.

Derivatives and techniques The Fund may use derivatives for reducing risks (hedging) and costs, but not to generate additional income or growth.

Strategy The Fund is managed to achieve a conservative (low) relative risk and reward profile.

SFDR category Article 6 (does not promote environmental and/or social characteristics or have a sustainable investment objective under EU regulations).

Base currency US dollar (USD).

Benchmark(s) 75% Bloomberg Barclays Aggregate Index and 25% MSCI All Country World Index. Used for performance comparison only.

Share Class Policy

Income and gains from the Fund's investments are not paid but instead are reflected in the Fund's share price.

Buying and selling shares

You may normally buy or sell shares on any day the New York Stock Exchange is open for business.

Intended retail investor

Investors who understand the risks of the Fund and plan to invest for at least 5 years. The Fund may appeal to investors who:

- are looking for a combination of income and investment growth
- are interested in exposure to a mixed asset allocation globally as part of a diversified portfolio
- have a low to medium risk profile and can tolerate significant short-term changes in the share price

Product availability The Fund is available to all investors with at least basic investment knowledge, through a wide range of distribution channels, with or without the need for advice.

Terms to understand

bonds, below investment grade: Bonds represent an obligation to repay a debt, along with interest. Below investment grade bonds generally pay higher interest rates but are considered less likely to make all scheduled payments or repay the initial debt.

derivatives: Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

emerging markets: Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

equities: Securities that represent partial ownership of a company.

What are the risks and what could I get in return?

Risk Indicator

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- USD 10 000 is invested
