What is this product?

Type

The product is a share class of Franklin Sterling Liquidity Fund (the "Fund") which is part of the Franklin Templeton Liquidity Funds Plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

To seek to maintain the principal of the Fund and to provide a return in line with money market rates.

This fund qualifies as a low volatility net asset value (LVNAV) money market fund.

Investment Policy

The Fund invests in high quality money market instruments and short-term bonds denominated in, or fully hedged GBP.

The Fund may arrange to enter into repurchase agreements. In a reverse repurchase agreement, the Fund arranges to buy public debt money market instruments from a seller with an agreement that the seller will repurchase the debt at a later date at an agreed price. The sellers are highly rated by recognised credit rating agencies. Such agreements allow the Fund to invest cash on a short-term basis.

SFDR category Article 8 (promotes environmental and/or social characteristics under EU regulations).

The investment manager applies a proprietary rating methodology using various ESG criteria to assess long-term opportunities and risks. The fund favours issuers with a high or improving profile and refrains from investing in issuers deemed among the poorest performers under certain sustainability metrics. The fund excludes or restricts investments in certain industries that are harmful to the environment or society, such as thermal coal, weapons and tobacco.

Share Class Policy

Income from the Fund's investments is paid monthly in the form of additional shares unless you elect to receive such distributions as cash.

Buying and selling shares

You may normally buy or sell shares on any day banks are open for business in England.

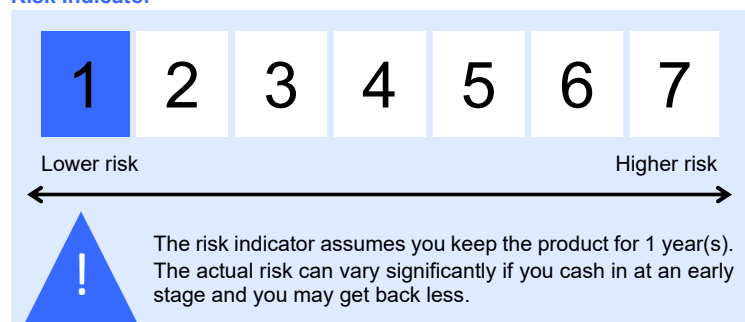

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets.

What happens if Franklin Templeton International Services S.à r.l. is unable to pay out?

Franklin Templeton International Services S.à r.l. ("FTIS") is the management company of the Fund, but the assets are held separately from FTIS by the depositary. BNY Mellon SA/NV Dublin Branch, as the appointed depositary of the Fund, is liable to the Fund or its shareholders for any loss of financial instruments held in custody by it or its delegates (cash could however be lost in case of default of the depositary or its delegates).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
- GBP 10 000 is invested

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 0.8% before costs and 0.7% after costs.

This Fund has no minimum required holding period. We consider that the 1 year recommended holding period is appropriate because the Fund is designed for short-term investment.
